Instructions for North Carolina ELT Application

Please use the attached form to set up your ELT access for North Carolina through Auto Data Direct, Inc. In order to record liens on vehicles, vessels or mobile homes titled in North Carolina, you will need to have a participant ID number issued by an authorized vendor such as Auto Data Direct, Inc.

ADD Account

In order to access your NC electronic lien titles through Auto Data Direct, Inc., you will need to have an ADD account. Customers with existing ADD accounts can add ELT access at no additional sign-up cost. Simply complete the required form, sign, then fax, email or mail it to ADD.

New users will need to create an ADD account. Go to www.add123.com/sign-up and follow instructions to create an account, or simply call the toll-free Customer Support line, (866) 923-3123, for help completing the process.


